**Wi-Fi Internet Service at Olympic House (the “Service”)**  
**Terms and Conditions**

1. Eligibility

- (a) To use the Service, you must be the hirers of Olympic House.
- (b) Please follow the Wireless User Guide which contains the exact procedure to connect to the Service.

2. Charges

- (a) The Service is charged on a session basis (i.e. 4 hours per session) to any user who has logged in successfully to the Wireless LAN network.
- (b) For NSAs:  
Each account is charged at HK\$150/session or HK\$400 for one day-pass (i.e. 0800 to 2300 hour).

**OR**

- (b) For Commercial or Sports-related Organizations:  
Each account is charged at HK\$200/session or HK\$550 for one day-pass (i.e. 0800 to 2300 hour).

3. Availability

- (a) The Service should comply with the IEEE 802.11n standard.
- (b) The Service is currently covering the Jockey Club Lecture Theatre, Board Room, and Meeting Rooms 1 to 7. The coverage is subject to be changed from time to time without prior notice.
